A regularly scheduled meeting of the Board of Trustees was held on Monday, October 16, 2023, in the Village Hall. Mayor Dodge opened the meeting at 7:00 p.m. Also present were Deputy Mayor Conley, Trustee Blumrick, Trustee McAvoy, Trustee Barr, Coordinator Bobbitt, Police Chief Swick, Fire Chief Czaja, Clerk-Treasurer VanBuren, and Tom Seaman, attorney.

Deputy Mayor Conley led the Pledge of Allegiance.

There were several residents, members of the Middleport Volunteer Fire Department, and members of other fire departments in attendance, as well.

Two members of the Gasport Memorial Post No. 1253 of the American Legion were in attendance to recognize Middleport Police Officer Joshua Mandaville. David Patton and Scott Wymyczak presented Officer Mandaville with the NYS American Legion Law Enforcement Officer of the Year Award for 2022-2023 and the Niagara County American Legion 8<sup>th</sup> District Law and Order Law Enforcement Officer Award. Assemblyman Mike Norris was unable to attend the meeting, but his office delivered a Proclamation for Officer Mandaville. Chief Swick read the Proclamation recognizing Officer Mandaville for his two heroic life-saving efforts in the line of duty last year. Kathy Kindle from the Middleport Clute-Phillips American Legion Post #938 also framed a newspaper article for Officer Mandaville.

Mayor Dodge opened the discussion regarding LOSAP (Length of Service Award Program) for the Middleport Volunteer Fire Department. He voiced his concerns regarding the letter the Middleport Volunteer Fire Department mailed out with misinformation as to the actual cost of the program the taxpayers would be voting on.

Darren Burdick stated that the 93 cents per thousand was if the Village amortized the cost over twenty years. Mayor Dodge said that it would be like buying a new car and paying for it over twenty years rather than ten years. Everyone knows that you would be paying a lot more, and the Village has no intention of doing that.

Darren Burdick would like the 53 cents per thousand to be referenced in the referendum. Attorney Seaman advised that the referendum has to go up for vote as the Village of Middleport administering the program. It is speculative at this point to reference a lower figure since an intermunicipal agreement would be negotiated at a later date.

Mayor Dodge opened the floor to those in attendance.

Allan VanBuren questioned how will the LOSAP program affect the overall Village budget going forward.

Kellie Lepard read a prepared statement thanking the firefighters for their service, but also expressing her disappointment in their actions since the last Village Board meeting.

Scott Kassmann talked about his years of serving as a volunteer firefighter for his community. He wants a special election to be held so the Village taxpayers can decide.

Mayor Dodge reintroduced the following resolution with the \$1.27 per thousand dollars of assessed property value.

Resolution of the Board of Trustees of the Village of Middleport, in the County of Niagara, State of New York, Calling a Special Election on December 5, 2023, Directing Publication of Notices of Election, and Determining Other Matters in Connection Therewith.

Resolved by the Village Board of Trustees of the Village of Middleport, by favorable vote of not less than 60% (3/5) of the members of the Middleport Board of Trustees, acting as the Fire Commissioners of the Village of Middleport Volunteer Fire Department, as follows:

Whereas, a length of service award program (LOSAP) is authorized by Article 11-a of the General Municipal Law; and

Whereas, the purpose of said legislation is to encourage volunteer firemen to remain active within their respective fire companies and further to promote interest in the volunteer service and to encourage new members to join and remain active as volunteer fire members; and

Whereas, the Village of Middleport Volunteer Fire Department has been incorporated as the Middleport Volunteer Fire Company No. 1, Inc., an incorporated volunteer fire company with its principal office in the Village of Middleport, New York, for the purposes of, among other things, to enable the Middleport Volunteer Fire Department/Middleport Volunteer Fire Company No. 1, Inc. to contract with municipalities, including the Village of Middleport and municipalities outside of the Village of Middleport, for the provision of fire protection services, and

Whereas, it is in the interest of the residents of the Village of Middleport to provide a LOSAP for the Village of Middleport Fire Department/Middleport Volunteer Fire Company No. 1, Inc.; and

Whereas, the Middleport Fire Department/Middleport Volunteer Fire Company No. 1, Inc. has contracts to provide fire protection services to the Village of Middleport, the Town of Royalton and the Town of Hartland; and

Whereas, Middleport Fire Department/Middleport Volunteer Fire Company No. 1, Inc. is entered into mutual aid agreements by and amongst various other Fire Companies and Fire Departments in the region, including but not limited to those Companies and Departments servicing the Town of Royalton Fire Protection District and the Gasport Fire District, and

Whereas it is the desire and intention of the Village of Middleport to seek intermunicipal cooperation agreements, to provide for the shared funding and administration of the various LOSAPs, with similarly situated municipalities in the region, where fire protection services are routinely covered through mutual aid agreements, such other municipalities to include, but potentially not be limited to, the Town of Royalton Fire Protection District and the Gasport Fire District, which are each seeking to each establish a LOSAP for the volunteer fire companies located within each municipality.

Now, Therefore, be it Resolved as follows

- Section 1. Board of Trustees of the Village of Middleport, acting as Commissioners of the Village of Middleport Volunteer Fire Department, does hereby approve the adoption of a length of service award program (LOSAP) as provided in Section 216 of the General Municipal Law, and shall conduct a mandatory referendum to determine whether the Village of Middleport shall establish and provide a defined benefit program for Active Volunteer Firefighters as provided in Section 215 and 219 of the General Municipal Law.
  - Section 2. The name of each fire company having volunteer firefighters who are potential participants in the Village of Middleport LOSAP program is as follows: Middleport Volunteer Fire Company No. 1, Inc. also known as the Middleport Volunteer Fire Department
  - Section 3. Board of Trustees of the Village of Middleport, acting as Commissioners of the Village of Middleport Volunteer Fire Department, shall administer the program as set forth in the Official Plan Document and be responsible for exercising the powers and duties conferred upon it. The Village of Middleport shall initially administer the program with the understanding that the Village of Middleport shall engage the services of qualified professionals to provide administrative and actuarial services including accounting, legal, and financial advisement services to assist it in administering the LOSAP
  - Section 4. The entitlement age under the LOSAP shall be 65. No payments shall be made to a participant without first reaching age 65, except in cases of death or disability for an Active Volunteer Firefighter.
  - Section 5. The estimated annual cost of LOSAP, based on the current existing

number of firefighters, is as follows: Total Annual Cost of \$70,190.00, which includes an Annual Administrative Fee of \$3,522. Such estimated annual cost would result in an approximate Village of Middleport property tax increase of \$1.27 per thousand dollars of assessed property value, (an approximate property tax increase of 10% per SBL Number).

- Section 6. To obtain a nonforfeitable and vested right to a service award, each participant must first obtain five years of Firefighting Service. The age to begin to participate in LOSAP shall be 18 years of age.
- Section 7. A year of "Firefighting Service" shall be credited in accordance with the "LOSAP Point System", a copy of which is attached hereto as Exhibit A, (or such adjusted point system duly adopted hereafter) for each calendar year after establishment of the program in which an active volunteer firefighter accumulates at least 50 points.
- Section 8. A participant who joins or rejoins after the age of 65, and who earns at least one year of Firefighting Service, is entitled to collect a service award for that year and for every subsequent year of Firefighting Service. A participant who does not have five years of Firefighting Service at the age of 65, but remains active after 65 and earns at least one year of Firefighting Service, is entitled to collect a service reward based on every year of Firefighting Service.
- Section 9. The amount of the contribution to the program to be made on behalf of each participant credited with a year of Firefighting Service shall be \$2,420,35.
- Section 10. The extent to which the program provides credit for years of Firefighting Service rendered during one or more of the five calendar years immediately preceding the establishment of the program is one year of credit for each year that Firefighting Services were rendered.
- Section 11. The timing and method of financing the contributions for fire service rendered by a participant during one or more of the five calendar years immediately preceding the adoption of the program shall be as follows: taxes shall be imposed and levied in the Village of Middleport for Budget Year 2024 and thereafter sufficient to pay the costs set forth in paragraphs 5 and 9.
- Section 12. The Defined Benefit award to be paid to eligible volunteer firefighters is projected to be \$20 per month for each qualified year of active Firefighting Service, not to exceed 20 years, with payment in any month not to exceed \$400, payment to commence when (1) the eligible volunteer firefighter reaches the stipulated entitlement age of 65 and has five years of qualified active Firefighting Service or (2) the eligible volunteer firefighter reaches the stipulated entitlement age of 65 and thereafter completes one year of active Firefighting Service. After payments commence, the amount of payment will increase by \$20 per month for each additional year of active Firefighting Service, subject to the \$400 cap.

Payment of the award shall be in the form of life annuity with 120 payments guaranteed. Any such payment shall be actuarially equivalent to any other method of payment, which may be permitted under the law.

Regular Defined Benefit award payments are authorized to commence one year after the date of the establishment of the LOSAP. Death and disability payments are authorized to commence upon the date of establishment of the LOSAP. Death and disability payments would be one-time lump sums actuarially equivalent to the 120 months as set forth

in the official Plan Document.

- Section 13. LOSAP shall take effect the first day of January next succeeding the date of the last voter approval required to establish the program.
- Section 14. All other provisions of the plan shall be in accordance with Article 11 A of the General Municipal Law as amended from time to time. Amendments to the plan shall be made pursuant to the General Municipal Law.
- Section 15. The proposition authorizing the adoption of the program shall be submitted to referendum at a special election of the qualified voters of the Village of Middleport on December 5, 2023.
- Section 16. A Special Election of the qualified voters of the Village of Middleport, County of Niagara, and State of New York, shall be held at the Village of Middleport Offices, located at 24 Main Street, Middleport, NY, 14105 on December 5, 2023, at noon (prevailing time) and the poll shall remain open until 9:00 o'clock, or as much longer as may be necessary to enable the voters then present to cast their votes. The cost of conducting the referendum shall be a charge to the Village of Middleport.

  The vote upon the Proposition to be submitted to the qualified voters shall be by paper ballot or absentee ballot, and the Village Clerk is hereby authorized and directed to have the necessary ballots prepared for use. Absentee ballots will be available upon request of the Village Clerk no later than December 4, 2023. The Absentee Ballot must be received by the Village Clerk no later than 9:00 pm on December 5, 2023.
- Section 17. Notice of the referendum/Special Election shall be published at least once, not less than 14 days prior to the date of the referendum in the Union & Journal.
- Section 18. The Village Clerk shall also cause said Notice to be posted in five conspicuous public places in the Village at least 34 days prior to the Special Election and by causing said Notice to be posted on the Village website at least 10 days prior to the Special Election.
- Section 19. The Village Clerk shall take all other steps necessary to carry out the intent and purpose of this resolution.
- Section 20. The following resident Village of Middleport electors, each of whom is a registered voter of the Village of Middleport, are hereby appointed to act as Election Inspectors and Ballot Clerks at the Special Election (either two or four): Rebecca Schweigert and Kathy Kindle, or such other qualified Election Inspector and Ballot Clerks as is hereby appointed at a later date by the Village Board of Trustees.
- Section 21. The Chairman and Inspectors of Election shall each be paid at the rate of \$15 per hour for the time necessary to prepare the register and the additional sum of \$15 per hour each for conducting the Special Election.
- Section 22. The Inspectors of Election shall meet at Village of Middleport Offices, located at 24 Main Street, Middleport, NY, 14105 on December 5, 2023, from 11:00 o'clock am until 12:00 o'clock pm to commence preparation of the register for the Special Election.
- Section 23. Preparing such register, the Inspectors of Election shall comply with the following procedure:

  (a) They shall adopt, use or copy from, the registration was certified and supplied by the County Board of Elections the names appearing thereon

of all persons residing in the Village of Middleport and qualified to vote

in such forth coming election.

- (b) The register for the Village of Middleport shall include at a minimum a space for the name of the voter, their address within the District, and a space for their signature to be signed by the voter on election day, and the space in which there shall entered the qualifications for voters.
- Section 24. The Village Clerk shall furnish the Inspectors of Election, at Village of Middleport, with all necessary registration books, papers, equipment, and supplies.
- Section 25. Said Notice of Preparation of Registration Role shall be in substantially the following form:

firefighters; stating the estimated annual administrative fee will be \$3,522.00; stating the estimated annual cost per covered firefighter will be \$2,420.35; stating that the expected estimated cost of the LOSAP program will result in an expected Village of Middleport property tax increase of \$1.27 per thousand dollars of assessed property value, (an approximate tax increase of 10% per parcel/ SBL Number); stating that each eligible participant may receive credit for up to five (5) qualified years of active Firefighting Service prior to the establishment of the LOSAP; stating that payment of the benefit shall be in the form of a life annuity with 120 payments guaranteed; stating death and disability payments to be authorized to commence upon the date of establishment of the LOSAP, and regular defined award payments to be authorized to commence one year thereafter, stating that the projected monthly award to be paid to eligible volunteer firefighters shall be \$20 per month for each qualified year of active Firefighting Service, not to exceed 20 years, with payment in any month not to exceed \$400, payment to commence when (1) the eligible volunteer firefighter reaches the stipulated entitlement age of 65 and has five years of qualified active Firefighting Service or (2) the eligible volunteer firefighter reaches the stipulated entitlement age of 65 and thereafter completes one year of active Firefighting Service, after payments commence, the amount of payment will increase by \$20 per month for each additional year of active Firefighting Service, subject to the \$400 monthly cap,

Shall such Resolution be approved?

A motion was made by Mayor Dodge to approve the preceding resolution authorizing the referendum of a special election to be held on Tuesday, December 5, 2023, for the establishment of a Length of Service Award Program (LOSAP) for the Middleport Volunteer Fire Department.

Chief Swick informed the Board the new 2023 Dodge Durango should be arriving at the end of the month or early November. He asked the Board to consider keeping the 2020 Ford Interceptor as a vehicle for one of the SRO officers use rather than putting it up for auction.

The adhoc committee completed their review of the employee handbook and turned it over to Attorney Seaman to finalize the handbook.

Clerk VanBuren reminded the Board and Department Heads again that the annual Sexual Harassment training and Violence in the Workplace Training needs to be completed before the end of the year.

The Town of Hartland Police Contract expires at the end of the year so negotiations need to start soon.

Clerk VanBuren asked the Board if she should get proposals for carpet tiles for the Board room and the Clerk's office or wait. They advised to get the proposals as they would like to see the Village Hall updated.

#### **New Business**

Clerk VanBuren told the Board that the 2023-2024 taxes will be relevied to the Niagara County Treasurer's office on or about November 1, 2023.

Discussed the unused coffee maker (circa 1999) and the coffee cart (circa 1970).

Village Historian Christa Lutz asked to continue the Hometown Heroes program for 2024 as long as she receives enough orders to meet the minimum order quantity.

The Village Tree Lighting will be held on Saturday, December 6, 2023, at 6 pm.

Coordinator Bobbitt asked the Board to consider purchasing a CCTV Van for \$10,000 from Custom Crews Inc as the lowest bid and with all of the camera equipment included. This would be used for the CMOM (Capacity Management, Operation, and Maintenance) program the Village has to comply with for the operation of the Wastewater Treatment Plant as mandated by the NYS DEC. He received the following quotes:

The vehicle is equipped with 1BAK KRA75 steerable camera tractor, 1BAK Orpheus camera, Flexidata (from Pipelogix) pipe survey reporting software loaded onto onboard computer system, 600' of cable, additional lighting ring, several tire/drive wheel configurations, onboard generator (vehicle engine driven) with 121.9 hours, all manuals for onboard equipment and software included. Carried, with all present voting aye.

A motion was made by Trustee Blumrick, and seconded by Deputy Mayor Conley, to enter into executive session for the purpose of consultation with the Village attorney and to discuss ongoing contract negotiations. Carried, with all present voting aye.

A motion was made by Deputy Mayor Conley, and seconded by Trustee Barr, to return to General Session. Carried, with all present voting aye.

General Session reconvened at 8:49 p.m.

There being no other business, a motion was made by Trustee Barr, and seconded by Deputy Mayor Conley, to adjourn. Carried, with all present voting aye.
