This Law shall take effect immediately upon filing with the Secretary of State.

DONALD HESCHKE PROPOSED NEW BUILDING ADDITION 6 & 8 MILL STREET, AND 3 N. MAIN STREET, MIDDLEPORT, NEW YORK

WHEREAS, Donald Heschke (the "Applicant"), has proposed a new building addition on premises located at 6 & 8 Mill Street, Middleport, NY, currently SBL Nos. 85.16-1-39 & 85.16-1-38, and 5 Terry Street, SBL No. 85.16-1-41 (the "Project"), which is being considered for Site Plan Approval by the Village of Middleport (the "Village"), and

WHEREAS, the Village Board has determined the project is an Unlisted Action under the State Environmental Quality Review Act and the implementing regulations of the New York State Department of Environmental Conservation adopted thereunder (6 NYCRR Part 617) (hereinafter collectively referred to as "SEQRA") for which coordinated review is not required; and

WHEREAS, the Village Board has considered the Project and reviewed the EAF in light of the criteria set forth in SEQRA in order to determine whether the Project will have a significant effect on the environment, now therefore be it

RESOLVED, that the Village Board of the Village of Middleport hereby declares itself lead agency for the purposes of SEQRA review of the Project, and be it further

RESOLVED, that the Project be classified as an Unlisted Action under SEQRA and that coordinated review is not required, and be it further

RESOLVED, that based upon the information set forth in the EAF, and for reasons more fully set forth in parts 2 and 3 of the EAF, the Village Board hereby determines that there will be no significant environmental impacts with regard to the Project, and hereby adopts and issues the attached Negative Declaration under SEQRA with respect thereto, and be it further

RESOLVED, that the Mayor of the Village be, and hereby is, authorized to execute any necessary documents in conjunction hereto.

A motion was made by Deputy Mayor Conley, and seconded by Trustee McAvoy, that the Site Plan application for 6 & 8 Mill Street has been reviewed by the Board of Trustees and the Building Inspector, Brian Belson. It has been determined that this site plan is an unlisted action pursuant to the State Environmental Quality Review Act (SEQRA), and that a negative declaration should be issued requiring no further action for SEQRA purposes based on the preceding resolution. Carried, with all present voting aye.

- 2) Approval is contingent on the applicant providing appropriate sidewalk space, designated as sidewalk, for use by pedestrians.
- 3) Approval allows for concrete pad at grade with the roadway to allow for vehicular access to parking areas.
- 4) Sidewalk access must remain available to pedestrians.

Correspondence

A letter was read from the United States Environmental Protection Agency (EPA) regarding the Village's response letters to the EPA's Pretreatment Inspection Report. The EPA is satisfied with the Village's response that they are declassifying FMC as a Significant Industrial User (SIU) so therefore the Potential Non-Compliance Items and Areas of Concern referenced in the EPA's letter no longer need to be addressed. Should the Village permit Significant Industrial Users (SIUs) in the future, the Village must ensure the SIU permits include all required conditions pursuant to 40 C.F.R. § 403.

New York Municipal Insurance Reciprocal (NYMIR) sent a letter notifying the Village that we must install working battery disconnect switches in the medium to heavy equipment owned by the Village.

Curtis Waugaman's resignation letter was read. He is resigning as a part-time police officer effective March 1, 2024.

The Arbor Day Foundation congratulated the Village on earning the recognition as a 2023 Tree City USA.

Old Business

The Canal Dock Improvement Project was discussed. The Village Board needs to make some decisions about moving forward with the project.

New Business

Clerk VanBuren requested that the Village close out the Capital Improvement bank account since there is currently no project utilizing this account. She had emails in support of this from the Vice President at Tompkins Community Bank as well as the Village accounting firm.

The Town of Royalton's Police Contract expires May 31, 2024, so a new contract needs to be negotiated as soon as possible.

The Middleport Beautification Committee requested the closure of Main Street from Church Street to State Street for National Night Out on Tuesday, August 6, 2024. The Village will have to submit a PERM₃₃C Application with the NYS DOT for approval.

A budget meeting was set for Saturday, March 2, 2024, at 9 a.m. in the Village Hall.

A motion was made by Trustee Blumrick, and seconded by Deputy Mayor Conley, to authorize the closing of the Capital Improvement bank account at Tompkins

Community Bank due to the fact that there is currently no need to have the account open since the two projects at the Wastewater Treatment Plant have been completed, there is a zero balance in the account, and all of the bills for those projects are paid. The Village is in long-term financing with NYS EFC (Environmental Facilities Corporation). Carried, with all present voting aye.

A motion was made by Trustee McAvoy, and seconded by Trustee Blumrick, to authorize the Village to enter into a Site Access Agreement with FMC for the 2024 remediation work scheduled to be completed in the Village of Middleport this year contingent upon Attorney Seaman's approval. Carried, with all present voting aye.

A motion was made by Trustee McAvoy, and seconded by Deputy Mayor Conley, to enter into Executive Session for the purpose of consultation with the Village's Attorney regarding a personnel matter. Carried, with all present voting aye.

Executive Session opened at 8:13 pm.

A motion was made by Deputy Mayor Conley, and seconded by Trustee McAvoy, to return to General Session. Carried, with all present voting aye.

General Session reconvened at 8:52 pm.

The next regularly scheduled meeting of the Board of Trustees will be held on Monday, March 18, 2024, at 7 pm.

There being no other business, a motion was made by Trustee Barr, and seconded by Deputy Mayor Conley, to adjourn. Carried, with all present voting aye.
