VEHICLE PURCHASE FROM MINI-BID

WHEREAS, the Village of Middleport solicited bids to purchase a Class 6 work truck with Switch-n-go Body Make and accessories through the New York State Mini-Bid process, which is authorized through the New York State Office of General Services (Group 40440, Award 23166), and

WHEREAS, the lowest responsive bid came from Towanda Automotive, Inc., now therefore be it

RESOLVED, that the Village of Middleport is hereby authorized to purchase the specified vehicle from Towanda Automotive, Inc., for a total cost of \$115,174.64, and be it further

RESOLVED, that the Village of Middleport Village Coordinator, Village Clerk and or Village Mayor is hereby authorized to execute any and all documentation necessary to effectuate such purchase, and be it further

RESOLVED, that such purchase documentation be executed by the end of 2024 and that the remaining Village of Middleport SLFRF (a.k.a. ARPA) funding be obligated for the purchase of such vehicle, as has previously been set forth by Village of Middleport resolution.

A motion was made by Deputy Mayor Blumrick, and seconded by Trustee LePard, to authorize Coordinator Bobbitt to purchase the 2023 Chevy Silverado MD work truck with a complete Switch-n-go body and accessories using the remaining SLFRF funds towards the purchase as stated in the preceding resolution. Carried, with all present voting aye.

The next regularly scheduled meeting of the Board of Trustees will be held on **Wednesday, January 22, 2025**, at 7:00 p.m. in the Village Hall.
